Gaston County's low-income, uninsured neighbors with chronic medical conditions can have their medical needs fully met thanks to the generosity of the healthcare community. HealthNet Gaston provides the healthcare system with a means to work together to help improve individual and community health.

Since 2009, HealthNet Gaston has coordinated \$77+ million in care for nearly 12,000 county residents. In addition to healthcare services, HealthNet Gaston provides patient education and navigation, access to affordable medications, and case management.

HealthNet Gaston has expanded its work to include helping people access health insurance through the Affordable Care Act (ACA) – which provides a premium subsidy for those with incomes up to 400% of Federal Poverty. Teaming up with its partners CaroMont Health and Gaston Family Health Services, HealthNet Gaston oversaw operations of the award-winning Health Insurance Information Center at Eastridge Mall. HealthNet Gaston is also part of the NC Navigator Consortium – the second-highest funded ACA navigator entity in the country with extraordinary success in reaching vulnerable populations to assist them in accessing affordable health insurance.

None of this would be possible without a strong and dedicated Board of Directors, an outstanding Staff and committed and engaged Community Partners. Thank you all!

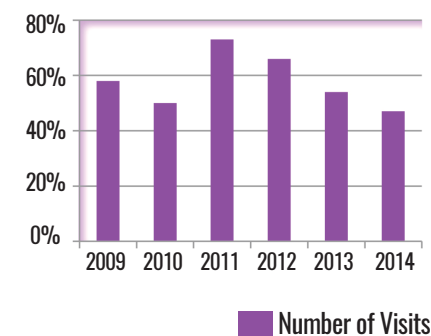

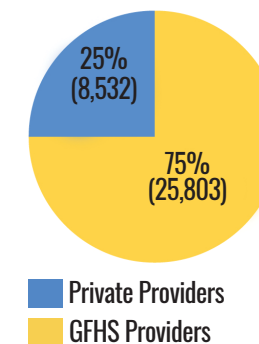

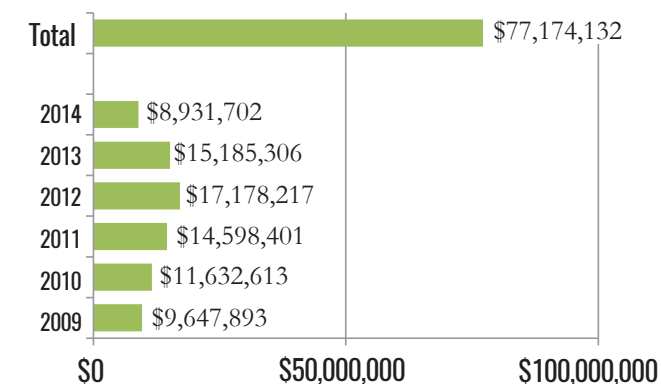
## ED Visits Per Patient
